### **1. Acceptance of These Terms**

By accessing or using the website at <https://fiveminwebsite.com> or any related services (together, the "Service") you agree to these Terms of Service ("Terms"). If you do not agree, do not use the Service.

### **2. The Service**

The Service lets you answer a short questionnaire and receive an automatically generated, fully editable website package ("Website Output"). Delivery is digital only.

### **3. Eligibility**

You must be at least 16 years old and have legal capacity to enter into a contract to use the Service.

### **4. Your Content**

but give 5MINWEBSITE a worldwide, non-exclusive licence to process it in order to provide the Service.

### **5. Orders and Payment**

- Prices are shown at checkout. Unless stated otherwise the current price is 5 USD or the equivalent in your local currency, processed by Stripe.
- The contract is formed when we send you the download link for the Website Output.
- 5MINWEBSITE never sees your full card details.

## 6. Delivery

Your Website Output is normally available for download immediately after successful payment and always within 24 hours.

## 7. Licence to Website Output

Once paid in full you receive a perpetual, worldwide, royalty-free license to use, modify and commercialize the specific Website Output delivered to you. 5MINWEBSITE retains all rights in its underlying software and brand.

## 8. Acceptable Use

You may not use the Service or any Website Output to:

- break the law or infringe rights;
- create hateful, discriminatory or unlawful content;
- reverse-engineer, copy or interfere with the Service;
- attempt unauthorised access to our systems.
